Currently, Mr. Ying is the operating partner of CDH Investments and an independent non-executive director of CHTC Fong's Industries Company Limited (恆天立信工業有限公司) (Stock Code: 641). Mr. Ying joined the Company since August 2013 as a non-executive director of the Company.
